Subject: Amendments to the 2021-2024 Transportation Improvement Program

The CT DOT is requesting several changes to the CNV MPO 2021-24 TIP, including the addition of several new projects.

#### Project No. 0174-0466 – Retaining Walls Pod 4C

Project 0174-0466 involved replacement, rehabilitation, and elimination of deficient retaining wall structures in a region designated Pod 4C, located in District 4.

The project's total cost is \$20,689,000. Federal share is \$16,471,000, and state share is \$4,118,000. There is no local share.

#### Project No. 0170-3688 – ALT/FCHT Connector Study

Project 0170-3688 is a proposed study to determine the best route to connect the State's two most significant and longest multi-use trails: the Farmington Canal Heritage Trail and the Air Line State Park. The connector would begin in Portland at the westernmost terminus of the ALT, connecting to the FCHT in Cheshire. Approximately half of the route of the ALT-FCT Connector has either been constructed in the form of existing off-road and on-road routes, or it has been planned or designed, or is in the process of being planned or designed by the municipalities. This project will identify and prioritize route options for the other half of the trail, which has not been studied in sufficient detail to allow it to be improved for safe and inviting bicycle transportation and recreation.

The project's total cost is \$350,000. Federal share is \$280,000, state share is \$35,000, and local share is \$35,000. The local match will come from a State Urban Act Grant awarded to the City of Middletown.

#### 1. Commencement of Meeting

Vice Chairman Mark Lauretti called the meeting to order at 10:02 a.m. Those in attendance recited the Pledge of Allegiance and the roll was called. There was no public comment.

#### 2. CNVMPO Meeting

a. Approval of CNVMPO Resolution 2023-09, TIP Amendments – Project Numbers 0170-3667, 0170-3668, 0170-3682, 0170-3684, 0171-0496, 0174-0442, 0151-0341, and 0130-0193 – Kevin Ellis described the projects. Project No. 0170-3667 involves Statewide Transportation Demand Management in CT, Project No. 0170-3668 involves Statewide Transportation Demand Management in NY, NJ and CT, Project No. 0170-3682 is for NEVI Program Phase 1 Administration, Project No. 0170-3684 is for Resiliency Improvement Plan and Vulnerability Assessment, Project No. 0171-0496 is to Replace, Remove, or Rehab Retaining Walls Pod 1A, Project No. 0174-0442 is to Replace Traffic Control Signals, Project No. 0151-0341 is to Widen I-84 Eastbound in Waterbury, and Project 0130-0193 is for I-84 Pavement Rehabilitation. On a motion by Gerry Smith, seconded by Jeff Caggiano, it was unanimously

VOTED: To adopt CNVMPO Resolution 2023-09, endorsing the TIP Amendments listed above.

b. Approval of CNVMPO Resolution 2023-10 – Endorsement of the Bridgeport-Stamford Urban Area Congestion Management Process – Rich Donovan said one of the federal requirements for transportation management areas or urban areas of greater than 200,000 residents is the development and maintenance of a congestion management process. As the CNVMPO has municipalities that are part of the Bridgeport-Stamford urban area, NVCOG staff worked in conjunction with Metro COG and West COG to develop an updated TMA-wide congestion management process. While NVCOG does not technically need to endorse this as an NVCOG process, because of the work staff put into it and the benefit it provides to NVCOG towns, it is worthwhile to do so. On a motion by Ed Mone, seconded by Joe Kilduff, it was unanimously

VOTED: To adopt CNVMPO Resolution 2023-10.

- c. Air Quality Conformity Determination Presentation and Public Comment Rich Donovan said CTDOT does air quality modeling for all projects included within the short-term TIP for the MPOs across the state, as well as in the long-range Metropolitan Transportation Plans. NVCOG received its air quality modeling conformity determination in February, which shows steadily declining emissions from transportation to well within the federal standards for each nonattainment area. A just under 40 day public comment period was held. No comments were received. Mr. Donovan opened the floor to public comment and/or questions. There were no questions or comments.
- d. Approval of CNVMPO Resolutions 2023-12, 2023-13, and 2023-14 Endorsement of CTDOT Air Quality Conformity Determination – Mr. Donovan said these three resolutions could be handled in one motion. Resolution 2023-12 is for conformity with the Clean Air Act, Greater Connecticut Ozone Nonattainment Zone, Resolution 2023-12 is for conformity with the Clean Air Act, Connecticut portion of the NY-NJ-CT Ozone Nonattainment Zone, and Resolution 2023-14 is for conformity with the Clean Air Act, Connecticut PM2.5 Nonattainment Zone. On a motion by Tom Dunn, seconded by Ed Mone, it was unanimously

VOTED: To adopt CNVMPO Resolutions 2023-12, 2023-13, and 2023-14.

- e. *NVision50 Presentation and Public Comment* Mr. Donovan said NVCOG staff worked for 15 months on this update to the CNVMPO Metropolitan Transportation Plan. The Plan, NVision50, represents the long-range goals and vision for transportation across the 15-town CNVMPO region. The plan looks at every mode of transportation in the region and develops a list of strategies and projects NVCOG staff would like to see happen over the course of the 28-year timeframe of the document. There is a focus on safety and also on maintaining the existing system with minor improvements, and expanding and improving transit services. The design and maintenance of multi-use trails has been incorporated into the document. The final draft document has been available for comment for just under 40 days. The comments received were for technical corrections and for the potential to use unused transportation rights-of-way for solar energy production. Mr. Donovan then opened the floor to public comment about NVision50 and the Metropolitan Transportation Plan. There were no comments.
- f. Approval of CNVMPO Resolution 2023-15 Adoption of NVision50: The Metropolitan Transportation Plan for the Naugatuck Valley COG and Central Naugatuck Valley MPO – On a motion by Ed Mone, seconded by George Temple, it was unanimously

- VOTED: To adopt CNVMPO Resolution 2023-15, endorsing NVision50: The Metropolitan Transportation Plan for the Naugatuck Valley COG and Central Naugatuck Valley MPO as the Metropolitan Transportation Plan for the Central Naugatuck Valley.
- g. Approval of CNVMPO Resolution 2023-11 Annual Urban Self Certification Mark Nielsen said that the Metropolitan Planning Rules require that at least every four years the Metropolitan Planning Organization certify that the planning process is addressing the major issues facing the area and is being conducted in accordance with applicable federal laws and regulations. On a motion by Ed Mone, seconded by Joe Kilduff, it was unanimously
  - VOTED: To adopt CNVMPO Resolution 2023-11, certifying that the transportation planning process is being conducted in accordance with federal requirements.

#### 3. NVCOG Administrative Items

- a. Approval of the Minutes of the February 17, 2023 CNVMPO and NVCOG Meeting On a motion by Joe Kilduff, seconded by Jeff Caggiano, it was unanimously
  - VOTED: To approve the minutes of the February 17, 2023 CNVMPO and NVCOG meeting.
- b. Approval of NVCOG Resolution 2023-15 FTA Capital Program Certifications and Assurances FY 23 – Mark Nielsen explained that since NVCOG is a direct recipient of FTA funding, each year it must adopt the FTA's Certifications and Assurances which apply to any project that uses FTA funds. The Certifications and Assurances were reviewed by NVCOG's attorney and assert that the agency will abide by the applicable provisions required by FTA. On a motion by Ed Mone, seconded by Jeff Caggiano, it was unanimously

VOTED: To adopt NVCOG Resolution 2023-15.

c. Approval of Agency Financial Reports and Summaries for the Period Ending 2/28/23 – Mike Szpryngel reviewed the financial report. NVCOG is eight months through the fiscal year with a net position of \$127,830 and is on target to break even at the end of the year. The cash balance is \$1.25 million, and the general fund has an unrestricted balance of \$878,826. Deferred revenue is \$1.1 million. NVCOG is on target for spending all major funding sources, there have been no unexpected funding cuts, and there is a possibility of additional funds. The expense summary shows that legal expenses for Kinneytown Dam have been high, but a \$60,000 reimbursement is expected through the NOAA grant. IT contracts and printing have been running high and will be adjusted in the budget revision. On a motion by Ed Mone, seconded by Jeff Caggiano, it was unanimously

VOTED: To adopt the NVCOG financial reports and summaries as presented.

- d. Review of FY 2022 Audit Report Mr. Szpryngel reviewed the agency audit report for the period ending 6/30/22. He said a deficit budget had been adopted and the agency has a net position surplus of \$30,749. The audit found no findings nor weaknesses in internal controls. The fiscal year ended with a cash balance of just under \$940,000, the general fund unrestricted balance was \$878,722, deferred revenue was \$595,259, and the actual indirect cost rate was 124.1%, which will be applied in FY 2024. There was a change in the net position of governmental activities of (\$83,624). Mr. Szpryngel explained this is a financial statement adjustment that the auditors made after their review. It is attributable to depreciation expense and how compensated absences are reported. He said that even though NVCOG is up \$30,749 on the books, just for financial statement analysis it is indicating a decrease, attributable as noted above. There was also a change to the audit report concerning the lease agreement. The GASB 87 rule compares the value of a short-term lease to the cost of NVCOG owning its own office space. Applying accounting principles, this rule compares the cost of paying interest to the cost of paying rent, and seeks to determine whether money would be saved or lost. In this case, over a five-year period, approximately \$32,000 would be saved by ownership, but the rule also makes an assumption of the fair market value of the leased space of the contract, so it is not exactly comparing apples to apples. Mr. Szpryngel said the new rule now shows the comparison, but it has no material impact.
- e. Approval of FY 2023 Mid-Year Budget Adjustments Mr. Szpryngel said he had sent a version of this report last week and First Selectman Mone had advised him of an error. There was a problem with how the formula calculated salary. He said that when he initially made the budget adjustments, the figures were a little different, and the error somehow came into play. Upon correction of the error, it brought him back to what he had initially calculated, so there will be some variance between the initial report and the one he sent out yesterday. He said the main reason for the budget adjustment is due to a significant increase in funding: IIJA funds of \$300,000 and an SMM grant of \$35,000. He still estimates a year end projection of \$0, a balanced budget. Additionally, some legal expenses for Kinneytown will be reimbursed through the NOAA grant, but not all of them. Updates and improvements must be made to the existing office space and will span this fiscal year and the next. The advertising and printing line items increased due to public outreach initiatives. Finally, there were some other expense adjustments, such as for office supplies, due to the increase in staff. Responding to a question from Mark Lauretti, Mr. Szpryngel said the variance column on page 3 of the fiscal year 2023 adjustment report outlines the line item increases from the FY 2023 adopted budget. Rick Dunne and Mr. Szpryngel responded to guestions about line items that increased. On a motion by Jeff Caggiano, seconded by Ed Mone, it was unanimously

VOTED: To adopt the FY 2023 budget adjustments as presented.

f. Approval of FY 2024 Preliminary Budget Estimates – Mr. Szpryngel said the approval of the preliminary budget estimates will not affect what the final budget will be. Mr. Szpryngel displayed a slide showing highlights of the FY 2024 preliminary budget estimate. These include a 9% increase in the overall budget, a significant increase in funding, and a \$0 year end projection (a balanced budget). Municipal dues are expected to increase by 3%, health insurance is projected to increase by 10%, advertising and printing will increase due to public outreach initiatives, and office equipment and renovations will increase due to updates and improvements to the existing space. Anticipated major projects are facility improvements, redesign of the NVCOG website, and the purchase of accounting and project management software. Rick Dunne noted that the final budget will not be adopted until June, most likely. On a motion by George Temple, seconded by Ed Mone, it was unanimously

VOTED: To adopt the NVCOG fiscal year 2024 preliminary budget estimates.

- g. Approval of NVCOG Resolution 2023-18, Endorsement of RPIP Grant Application for Ansonia Regional Senior Center – Drew Baklik explained that, if awarded, this grant would serve parts of the lower Naugatuck Valley. On a motion by Ed Mone, seconded by George Temple, it was unanimously
  - VOTED: To adopt NVCOG Resolution 2023-18, endorsing the RPIP grant application for the Ansonia Regional Senior Center.
- h. Approval of NVCOG Resolution 2023-19, Endorsement of RPIP Grant Application for Lower Valley Emergency Drone Fleet – Mr. Baklik said this application was spearheaded by the fire departments with anticipated additional participation by the police departments and EMS. This application is expected to be submitted in August 2023. On a motion by Jeff Caggiano, seconded by Tom Dunn, it was unanimously
  - VOTED: To adopt NVCOG Resolution 2023-19, endorsing the RPIP grant application for a lower Valley emergency drone fleet.
- i. Director's Report
  - Legislative Update Drew Baklik said staff is tracking dozens of relevant bills. All municipal solid waste bills are on hold until the JF deadline and are likely to continue to evolve afterwards. HB 6781 and other bills concerning affordable housing and tenants' rights continue to draw attention from the public and both sides of the aisle. HB 6742 outlines some changes to the bonding authorization for commercial rail freight lines, HB 5989 has to do with changes to the LOTCIP program, ASB 1042 would authorize DECD to provide capacity building grants to brownfield land banks, SB 1141 is focused on transit-oriented development, substitute house bill 6482 will authorize up to \$3 million per year from FY 2025 to 2029 to support bikeways, greenways, and rec trails. Senate bill 935 is the CMERS bill that would mandate municipalities to provide police and firefighters with CMERS pensions or pensions that are comparable or superior. Mr. Baklik said after the JF deadline passes, he will begin providing weekly bill updates to the CEOs. Sheila O'Malley commended Mr. Baklik for his efforts in legislative tracking.

#### 4. Emergency Management

Joanna Rogalski said the Chesprocott Health District is planning to relocate to a two-acre parcel of land off Sandbank Road in Cheshire and needs to raise an additional \$1 million for a new facility. Drew Baklik is helping the health district explore funding sources. The annual emergency management symposium will take place on April 25 at Aria in Prospect.

- a. Regional Emergency Planning Team Update The recently adopted Region 5 Public Works Mutual Aid Plan was activated on 3/14/23 due to the Nor'easter which caused numerous blocked roads in the Town of Goshen. A course about creating effective training plans for disaster response will be held on March 22 and March 23, from 8 a.m. to 5 p.m., at the Litchfield County Regional Fire School. The Texas A&M extension service will be facilitating the training.
- b. Community Emergency Response Team Update At the DEMHS Community Preparedness Strategic Planning and Grants Unit, Michael Davis is now the person to contact for funding requests and grant-related submissions. CERT is offering a free trainthe-trainer course that will be held on March 25. The next statewide Citizens Corp council meeting will be held on April 20.

Additionally, John Field also spoke about the Public Works Mutual Aid plan that was activated in Goshen. He was impressed with the overwhelming response he received after putting out the request for aid. All municipalities that responded are members of NVCOG. Thomaston, Watertown, and Wolcott sent crews which accomplished a great deal, and Mr. Field offered the crews and the municipalities kudos. He noted that many other municipalities responded as well, but ultimately ended up not being used for assistance. An anthrax tabletop exercise will be held on March 21 in Litchfield. A plan called Rapid Welcome has been developed for migrant preparedness. A flood workshop with the Army Corps of Engineers will be held on June 21. He also said that Derby and Ansonia should be aware that CTDOT is working on a Route 8 highway diversion update.

#### 5. NVCOG Planning/Transportation

- a. Approval of NVCOG Resolution 2023-21 Amendment to the MOU between Valley Transit District and NVCOG – Mark Nielsen explained that since NVCOG is the designated direct recipient for federal funds provided by FTA for the lower Valley portion of the Bridgeport-Stamford urban area, the FTA requires that NVCOG and the Valley Transit District (VTD) execute a Memorandum of Understanding (MOU) defining roles and responsibilities. Accordingly, NVCOG and VTD executed an updated MOU in December 2020. Due to federal funds being made available under the CARES Act and ARPA to respond to the COVID-19 pandemic, FTA has asked that the MOU be revised to include reference to these funding sources. On a motion by Jeff Caggiano, seconded by Joe Kilduff, it was unanimously
  - VOTED: To adopt NVCOG Resolution 2023-21, endorsing the updated NVCOG-VTD Memorandum of Understanding.
- b. Safe Streets for All (SS4A) Project Application Debrief Mr. Nielsen said NVCOG had submitted an application for the USDOT Safe Streets for All discretionary grant program. Notification was received that NVCOG's application was not awarded and a debrief was held with USDOT. While the application was "Recommended" for award, because of the number of applications submitted, only proposals ranked "Highly Recommended" were awarded. USDOT's review noted several areas that needed to be strengthened on NVCOG's application. USDOT anticipates announcing the Notice of Funding Opportunity for the next round of SS4A funds in April. NVCOG plans to revise the previous

application to address the deficiencies noted in the debriefing meeting.

- c. LOTCIP
  - i. Approval of NVCOG Resolution 2023-16, New Project Oxford, Chestnut Tree Hill Road – Kevin Ellis said this project will reconstruct Chestnut Tree Hill Road in Oxford from Oxford Road (Rt. 67) at the south to Chestnut Tree Hill Road Extension (Rt. 42) at the north. The length of the project is approximately 6,870 feet. The roadway will require full-depth reconstruction and will widen the roadway to 26 feet. A drainage analysis will be performed during design. It is anticipated that the analysis will recommend a new storm drainage system. The current project construction cost is estimated at about \$6.51 million. The municipality will be responsible for all associated design costs. NVCOG's Transportation Technical Advisory Committee (TTAC) met earlier in the month and recommends this project move forward. On a motion by Gerry Smith, seconded by Tom Dunn, it was unanimously
    - VOTED: To adopt NVCOG Resolution 2023-16, committing regionally apportioned LOTCIP funds to the above-described roadway reconstruction project in the Town of Oxford.
  - Approval of NVCOG Resolution 2023-17, New Engineering On-Call List Karen ii. Svetz explained that the LOTCIP program allocates state funds along planning region boundaries. NVCOG has the responsibility to select eligible projects and distribute funds to member municipalities to construct transportation improvement projects. As part of the program guidelines, the municipal sponsors are responsible for completing the design process and NVCOG is required to certify that the project plans and specifications meet design standards established by the program. To facilitate this process, the NVCOG endorsed a consulting engineer on-call list at its October 11, 2019 meeting. This list included seven firms. At its November 4, 2022 meeting, the NVCOG exercised its option to extend the term of this list by six months. NVCOG uses this list to solicit proposals for third-party engineering reviews and other design services. An RFQ was issued to solicit responses from qualified and experienced engineering firms to perform on-call transportation engineering and program management related to the project design review and other tasks. The deadline for proposals was December 16, 2022. Eighteen proposals were received. A TTAC selection committee met on February 8, 2023 to review the proposals. Based on the review process, the committee recommends the top nine firms be included on the new engineering on-call list. Ms. Svetz said this list is also open to municipalities to use for things other than LOTCIP projects. On a motion by Tom Dunn, seconded by Jeff Caggiano, it was unanimously
    - VOTED: To adopt NVCOG Resolution 2023-17, endorsing the Engineering On-Call list.

#### 6. Environmental Planning

a. *Household Hazardous Waste Collection, April 22* – Christine O'Neill said the 2023 HHW collection dates and locations have been finalized. All the events will take place from 8

a.m. to 2 p.m. The first event will be held on April 22 at the Shepardson Community Center in Middlebury, the second event will be held on July 22 at Quaker Farms School in Oxford, and the third and final event of the year will be held on September 23 at Thomaston High School in Thomaston.

- b. *MSW & Recycling Update* Ms. O'Neill said Ansonia, Seymour, and Woodbury are continuing their sustainable materials management programs along with several other communities throughout the state. Woodbury, in particular, has seen great success with increases week over week of diverted food waste. Town hall style meetings are being planned to gather qualitative feedback from residents. Additionally, NVCOG has begun planning for its annual composter and rain barrel sale.
- c. Approval of NVCOG Resolution 2023-20, Endorsement of Regional Waste Authority Study Grant Application – Aaron Budris said CT DEEP is accepting proposals through a new grant program to help municipalities and regions evaluate interest in and assist in expanding existing, or creating new, regional waste authorities. NVCOG staff has drafted a proposal that would fund a study to investigate the region's capacities and needs and how a new or expanded regional waste authority could help municipal efforts. The application deadline is March 30. Mr. Budris said he is looking for the board's support for this application. On a motion by Ed St. John, seconded by Tom Dunn, it was unanimously
  - VOTED: To adopt NVCOG Resolution 2023-20 endorsing the completion and submission of an application to CT DEEP's Regional Waste Authority Grant Program for the purpose of conducting a study regarding the possible formation of an RWA in or around the NVCOG region.
